## Welcome to Newsletter 89 of the Oxford Pedestrians Association

**OxPA is not political!** In our last Newsletter there was a reference to the well-recognised constitutional anomaly that transport policy for Oxford City is determined by the Oxfordshire County Council's ruling party, which does not contain any members elected by City constituencies. A complaint has been received that our comment indicates that OxPA has some kind of political affiliation. Not so. OxPA is strictly non-political, and, as our record shows, supports good ideas and opposes bad ones regardless of their political origins.

**Oxford Streets for People:** September 22nd is the traditional date for European Car Free Day - or *In town without my Car* - as it later became known. There has been an Oxford celebration on September 22nd since 2001, if not before, and this year it takes place during European Mobility Week, when the Oxford Civic Society will work with the City Council to promote **Oxford Streets 2009**. The aim is to transform our streets into spaces for all, to encourage local groups to hold street parties and events during the weekend September 19/20th, when people will be able to enjoy their streets without motor traffic. ### **Local Transport Plan 3: Sept 4th deadline**

Consultations for the third LTP have begun and stakeholders are being encouraged to contribute at various stages of the fifteen-month process before implementation in

To ensure maximum focus on the needs of more vulnerable road-users, OxPA has worked with other travel groups to create the **Oxfordshire Active Travel Strategy**. This will be distributed to local groups throughout the County in time to help them in persuading County Transport Planners to implement best practice for improved walkability.

### **New Inn Hall Street**

The appearance of New Hall Street after weeks of road works has left many of us somewhat disappointed! What began as a splendid vision of equality for walkers, with no kerbs and a level surface, has sadly materialised as a wider road with ugly yellow lines. However, we are very heartened to learn from the responsible County Officer that this is merely a short transitory phase. The yellow lines are only reflective tape which will be easily removed without damaging the new surface just as soon as the Department for Transport (DfT) gives

approval to designation of the whole street as a restricted parking zone. Once this is in place it will be possible to ticket any vehicle infringing the restriction. Let's hope DfT gives permission soon before the beautiful paving stones and cobbles are damaged by illegal parking. A further encouraging point is that the black asphalt will become more muted as it ages, blending in with the natural colour of the chippings to produce a more appropriate tone for an Oxford street.

### **More blocked pavements**

Parked cars are not the only obstacles to free movement for pedestrians on Oxford's narrow pavements. Residents in East Oxford have found that wheelie bins are being left outside front gardens, in spite of Council instructions to the contrary. If you or your neighbours are inconvenienced – or even house-bound – by your pavement made impassable, send us your details and get in touch with your City Councillor to ask why Council bin collectors are not leaving wheelie bins and re-cycling boxes more considerately.

### **Child-shaped bollards help slow traffic**

They may look like a new foe for Doctor Who, but child-shaped bollards that give the impression they are about to cross the road are the latest attempt by a council to slow drivers as they pass local schools (see photo on website). The steel mannequins cost £350 each and have been placed outside Avenue Primary School in Leicester to help enforce a 20mph speed limit. The

danger faced by children is highlighted by the fact that one of these bollards has already been knocked over.
