Botley Road audit



Botley Road is currently closed to traffic at the railway bridge for six months. In order to find out what the closure means for pedestrians, OxPA held our first outdoor meeting of 2023 there in April, when the road had been closed for a fortnight.

We gathered on Frideswide Square on the wide (shared) pavement in front of the Said Business School, but reaching the tunnel on the south side of the bridge required crossing the square, not always easy. And the tunnel has never been the most welcoming space - dark and covered with graffiti.

Two weeks into the closure, most people seemed to have got used to it, although a minority of cyclists were riding through rather than pushing.





The photo shows a food delivery driver pushing their bike, and we saw a motorcyclist dismount and push - but there are pinch points by the lampposts. Network Rail has provided marshals who were on duty at each end of the tunnel, and also at Mill Street where there are turning vehicles. Approaching Osney Bridge, the pavement gets very narrow.

Pedestrians who need to catch a bus from town must now walk to St Frideswide's Church, nearly half a mile. The westbound bus stop has very little space for passengers to wait, while on the opposite side of Botley Road, signs warning motorists about the closure also serve to obstruct the pavement at the bus stop.

Our group noted that the pedestrian crossings are poorly located: there is a desire line between the church and West Oxford Community Centre, but the crossing is offset 40 yards, and at Ferry Hinksey Road, reaching the lights-controlled crossing requires a similarly long detour.



We took the main road (Bridge Street) on to Osney Island. The road is wide here, with space for cars dominating the access to a small island, yet the pavement on the east side is cobbled, making it inaccessible for anyone using a wheelchair. The pavements in Osney are narrow with a poor camber towards the kerb. There are few front gardens, so bikes are left obstructing the pavement - but there is plenty of on-street car parking, some of which could be exchanged for multiple bike racks.

We finished at a riverside pub, The Punter. The main entrance has three steps and no handrail; there is a small ramp into the beer garden, but the nearest dropped kerb is all the way around the corner!

Nonetheless, our group enjoyed a well-earned drink in the garden.

Network Rail appear to be active in monitoring the works. They have given the railway tunnel a fresh coat of print (inevitably attracting new graffiti!) and are making arrangements to relocate the westbound bus stop. Oxford Open Doors – request for volunteer couriers

We have been approached by Oxford Preservation Trust to co-ordinate, once more, a cohort of volunteers to deliver, **on foot or by bicycle,** venue packs for the sites participating in this year's Oxford Open Doors weekend, taking place from the 9th – 10th September.

Volunteering would involve collecting a few donation buckets and venue packs from OPT offices at 10

Turn Again Lane, OX1 1QL towards the end of August and delivering them on foot or by bicycle before 4th September. The collection buckets are for city centre venues within easy walking distance of OPT offices. Delivery of venue packs further from the city centre is allocated to volunteers on bicycles.

The venue packs are A4 envelopes containing information and leaflets for the participating venues. There's no need to commit at this stage. However, if those potentially interested can let me know, then I'll send them further details.

HIF1 road rejected

Oxfordshire County Council last week, against the planning advice of County officers (John Disley and Owen Jenkins), rejected the proposal to build a big

new road in south Oxfordshire dubbed the HIF1. This is a triumph of groups working together, and courageous councillors voting against officers' advice. As one of the groups opposing the road building OxPA cited County policies to reduce car dependency and promote walking, cycling and public transport use - and it was the departure from County policies that led to the rejection of the road building plans.

JR Hospital pedestrian audit

OxPA audited access at the JR hospital site on foot and found it a positively hostile environment for pedestrians, who have no direct routes from the entrance to the site to the main JR hospital entrance, and whose needs are at or near the bottom of the road users' hierarchy. Pavements on the JR site are narrow, sloped, dirty, neglected and indirect.

Headington Festival stall

On Sunday 4th June we had a stall at Headington Festival. As always our pavement parking stickers were the best seller. We noticed that more people than usual seemed angry about pavements and road issues, and had to explain repeatedly that we are not a part of the Council but a small lobby group doing our best with our small resources.
