## Pavement clutter on Botley Road



A survey of the closed Botley Road shows the clutter that is placed on pavements even when the road is almost empty of motorised traffic. Both sides of the road are full of plastic signs and fencing, with the added issue of leaves not adequately cleared. At the time of writing the street is further compromised by flooding, which cannot be helped but which often leaves further debris in its wake.

OxPA created <u>this</u> presentation to show the issues for pavement users. From the narrow single file tunnel used by motor-cyclists and cyclists wheeling their vehicles, slow and fast walkers, wheelchair and buggy users, and thousands of people on foot, to the negotiating of a plethora of road signs, to plastic fencing and neglected surfaces, it is a tribute to pavement users that they continue to manage the street at all. Workers' signs are routinely placed on pavements all over Oxfordshire, even when they cannot be seen from the road. We are using photographs taken along routes to raise awareness of issues of pavement clutter and obstruction, as done in this presentation, which demonstrates some of the obstructions to pavement users on Botley Road.

#### Safe Pavements For All

City Councillor Barbara Coyne has started a 'Safe Pavements For All ' campaign which OxPA is actively working to support.

Our first and very seasonal call is for salt bins to be made available to all communities to de-ice pavements when it gets cold and wet. However this is just the beginning; loose paving stones, potholes, very large puddles on pavements (like the one on Park End St), and swathes of leaves left to rot also make trip and slip falls a risk for pavement users. This is particularly an issue in wet and wintry weather, when loose paving stones like the many on St Aldates can soak a person's foot and leg in cold dirty water, and mud and ice can mean broken wrists or worse for those who slip or trip.

We look forward to the coming year of working with the Safer Pavements For All campaign to address some of the issues that make walking and wheeling unsafe or impossible.

#### **Pavement Closure on Botley Road**

Thames Water will be <u>closing the north pavement of</u> <u>the bridge</u> over the Thames on Botley Road from March 2024 to March 2025 to complete the works . This leaves pedestrians with only a substandard, too narrow pavement on the south side, and closes off the Thames Path which is used as an off road route for pedestrians and cyclists accessing Botley Road from the north. Apparently this will mean single file motorised traffic over the bridge.

#### Cycling on Queen St and Cornmarket

Following our submission of OxPA members' responses to the question of bringing cycling back to Queen St and Cornmarket, the County Council has decided to carry out further surveys of their own before coming to a conclusion. These surveys will include a focus on fast e-scooters and e-bikes.

Thanks are due to all those of you who responded it was a very helpful survey and showed that on the whole OxPA does not support the bringing back of cyclists to either street during the hours of 10am to 6pm.

# Petition for greater priority for pedestrians at pedestrian-operated traffic lights
